



## Volunteer Deputy Launching Authority (DLA)

<b>Why the RNLI needs this role:</b>	<b>This role will help us save lives at sea by carrying out the day to day management of the lifeboat station to ensure a permanent state of readiness for service.</b>
<b>Potential time commitment:</b>	Variable
<b>Team:</b>	Community Lifesaving
<b>Responsible to:</b>	Lifeboat Operations Manager (LOM (or the Divisional Operations Manager (DOM) when actively deputising)
<b>Responsible for:</b>	Station personnel and volunteers in the absence of the LOM
<b>Role specific requirements:</b>	<ul style="list-style-type: none"> <li>Stepping down age 70</li> <li>May be subject to DBS/PVG/Garda checks during the recruitment process</li> </ul>
<b>This role involves:</b>	<ul style="list-style-type: none"> <li>Complying with the RNLI Volunteer Commitment</li> <li>Authorising launch of the lifeboats (and hovercraft if appropriate), in accordance with current launching procedures</li> <li><b>In the absence of the LOM or as delegated locally:</b></li> <li>Ensuring all operational activities are carried out to maintain the lifeboat and all associated equipment in a constant state of readiness for launching on service</li> <li>Leading the operations team and be a member of and represent operations on the lifeboat management group (LMG)</li> <li>Keeping the LMG chairman regularly apprised of relevant operational matters</li> <li>Liaising and maintaining close links with all local emergency services and representing the RNLI's interests locally in all operational matters</li> <li>Ensuring regular meetings are held with the operations team and encourage open communication</li> <li>In co-operation with the relevant RNLI personnel, ensuring that the RNLI Competency Based Training (CoBT) requirements for staff and volunteers are fulfilled</li> <li>Being involved in other activities as required</li> </ul>
<b>Training and support:</b>	<ul style="list-style-type: none"> <li>CoBT will be provided and should be maintained in order to perform this role</li> <li>Coaching, mentoring and formal training courses</li> </ul>
