## **Main Purpose**

We are looking for a dedicated individual to join our finance team. The Donor Care supervisor and Legacy Administrator will be responsible for 2 main areas. The first will be managing the donor care team, and to provide advice and help for all tasks performed by the team. The second will be to manage all legacy administration. The post holder will also represent Mercy Ships whilst liaising with solicitors, personal executors and legacy staff from other charities and will be expected to develop and implement legacy administration processes to manage and grow future income.

This is an exciting opportunity for an enthusiastic individual to use their skills and experience to make a positive impact on the lives of those in need.

# **Main Responsibilities**

#### **Donor Care Supervisor**

- Oversee and supervise the donor care staff team, delegating tasks where necessary and monitoring the team's performance
- Help to develop our donors' understanding of how their support makes a difference,
- Support the finance team with administrative tasks.
- Taking telephone calls and processing donations as per supporter requirements
- Utilise persuasive skills, encouraging donors to continue and develop their support by giving them different options and opportunities.
- Dealing with email orders and responding / processing as required.
- Keying donations accurately and correctly onto the appropriate databases and computer systems.
- Providing an outstanding level of supporter care via the telephone or email using professional business level English both spoken and in writing (for email correspondence).
- Dealing with and resolving supporter queries, which may include investigating issues and putting corrective action in place
- Resolving any supporter complaints effectively
- Other duties as are within the scope, spirit and purpose of the job as requested by the line manager
- Post holder will actively follow Mercy Ships UK policies

## **Legacy Administration**

- Act as the main contact for legacy estate enquiries, ensuring all correspondence and income is received and recorded in the correct places.
- Responsible for the administration of all legacy case files including residuary and pecuniary gifts.
   Operating within agreed schedules and processes.
- Liaise effectively with key internal and external stakeholders, including senior staff, solicitors, personal executors, next of kin and other charities, making recommendations to maximise the legacy value whilst maintaining the reputation of Mercy Ships.

- Maintain the legacy files with all relevant information relating to legacy cases.
- Develop appropriate communications for use when communicating with executors and next of kin.
- Ensure that all relevant provisions of the Charities Act 1993 are observed, seeking legacy advice where appropriate.
- Keep abreast of industry developments and relevant laws, undertaking training where necessary.
